Annual Parish Meeting 10th May 2023 7.00pm (before the Annual Meeting of the Parish Council)

The Annual Parish Meeting is not a Parish Council meeting. The Local Government Act states that every parish must hold Parish Meeting a year. If there is a Parish Council, the Chairman of the Parish Council (or vice-chair if the Chairman is unable to attend) must preside. If there is not a Parish Council then a Chairman is elected by the meeting itself. The Agenda is a standard agenda, to give reports on the business of the last 12 months. The Parish Council reports to its electorate on its activities over the last year and there are usually reports from County and District Councillors and perhaps from any voluntary or local community groups. It is also an opportunity for parishioners to question people and organisations on any issues relating to the village. As the Annual Parish Meeting is not a parish council meeting it is not conducted in the same way or governed by the same rules as a parish council meeting. Members of the public are permitted to make statements on relevant matters during the meeting. Any resolutions passed do not bind the Parish Council.
